Instructions for Completing the Application

1. All applications submitted on or after September 1, 2011 must include documentation of completing either Route A, B, or C of the requirements (see page 2 for details).
2. For university courses, attach original transcripts (internet transcripts are not acceptable), *with the courses highlighted*. In some cases, the university course name on the transcript is non-specific, e.g. "Special Topics in Education." If this is the case, submit either a syllabus from the course or a letter from the instructor or department verifying that the course meets the requirement.
3. All applications submitted on or after September 1, 2011 must include documentation of passing either the ACTFL OPI or the UFLA Oral Proficiency Test at the Advanced Mid level.
4. Mailing information is found on Page 3.

University and Professional Development Courses Approved by USOE

1. Courses are to be a minimum of three semester hours.
2. Courses are to be 3000 level or above.
3. Courses are to be taken within five years of the date of this application.
4. Courses taken online will be accepted if through an accredited university.
5. Professional Development courses must be pre-approved by USOE and entered in OnTrack.

- Advanced Mid or higher oral proficiency on the ACTFL scale

Route B: Out of State Credentials (varies by State)

- (e.g. University of Minnesota's Dual Language/Immersion Certificate)
- Advanced Mid or higher oral proficiency on the ACTFL scale

Route C: USOE PD Route (12 credits + years of successful teaching

(Only available until September 1, 2013)

- Dual Immersion 101 (3 credits)
 - Dual Immersion 102 (3 credits)
 - AUDII 101 (3 credits)
 - AUDII 102 (3 credits)
 - Advanced Mid or higher oral proficiency on the ACTFL scale

State Approved Endorsement Program (SAEP)

1. An approved SAEP for Dual Immersion allows a Licensed Teacher to teach Dual Immersion classes while working on the Dual Immersion Endorsement—meaning they are not yet highly qualified in Dual Immersion.
2. The applicant has two years from the date the SAEP is approved to complete all requirements for the endorsement.
3. The applicant must document either a minimum of six hours toward the endorsement or already have a World Language Endorsement in the language of instruction before applying for the SAEP.

4. Attach original transcript(s) and/or OnTrack printouts *with the relevant courses highlighted*.
